

## 4Children Response to Department for Education consultation on Revision of the 'SEND code of practice: 0 to 25 years'

1 Does the Code clearly reflect the changes made to the consultation draft to take account of the amendments to the Children and Families Bill to include disabled children and young people in the provisions on identifying children and young people, integrating education, health and care provision, joint commissioning, the local offer and providing information and advice? (Chapters 1, 2, 3 and 4)

In particular we acknowledge the particular improvement that has been made by adding a dedicated section – Section 5 - on early years which raises its status and helps to support early years within the local offer.

The recent revised Early Years Foundation stage framework published by the Department for Education on 31 March has removed the requirement for a named Special Educational Needs Coordinator (SENCO) for settings outside of nursery settings, and the additional early years chapter in the new code of practice 2014 can help to address this absence, something that will be strengthened further still through a new specific implementation guide / information sheet.
